Partnerships: Joining hands with the AQUA Institute

In 2013 evaplan formally set up a joint venture with the renowned Institute for Applied Quality Improvement and Research in Health Care (AQUA Institute www.aqua-institute.de).

The AQUA Institute is one of the most experienced and successful providers of concepts and problem solving in the field of healthcare quality improvement in Germany. Since 1995 AQUA has been developing systemic, comprehensive and evidence-based tools for improving the quality of health services. This integrated Quality Improvement approach has been formalised into the 'European Practice Assessment (EPA)' and implemented widely in Germany as well as in other European countries. Moreover, the AQUA-Institute is commissioned with the implementation of a nationwide cross-sectoral quality assurance scheme of the German healthcare system.

Since 2011 evaplan is working in a consortium with AQUA in Low and Middle Income Countries including Kenya, Algeria, India and Tanzania to implement integrated quality improvement approaches (see next page).

Improving Health Care in Kenya, Tanzania and Algeria

Developing adapted and integrated approaches for systemic and continuous QI in health care - based on evidence, is the main objective of our latest quality improvement initiatives in Kenya, Tanzania and Algeria. The participatory indicator based systems assess the quality of health care from various perspectives, including patient, staff, management and facilitators. This provides an opportunity for health facilities to benchmark themselves with other facilities and monitor their own results over time. The projects have successfully made use of Visotool ®software, developed by AQUA, a specialised software that allows precise analysis visualisation, benchmarking and supports the health facilities to develop QI action plans. Additionally, our tools provide precise measurement of quality problems, allowing prioritizing action according to the Pareto principle. Results demonstrated that this integrated approach is an effective low cost, high impact and innovative solution to capitalize available resources and strengthen quality of service delivery. Going beyond: There is more potential to this approach. Linking with accreditation, results based financing approaches or even going beyond health care, are avenues to be explored.

Harmonizing and Integrating Quality Improvement approaches in the local context

The proliferation of different quality improvement (QI) approaches, and the need to adapt them into local country and organizational contexts, has been highlighted by several researchers (Atun 2012; Massoud et. al. 2012; Sax & Marx 2013). The need for clarifying differences and similarities in QI approaches, in order to maximize their benefits, is also a topic of debate in the literature (Walsche 2009, Tawfik 2010) and in various countries (Bangladesh, Afghanistan, Tanzania). But what mechanisms exist to drive this harmonization, and what is the experience of attempts at harmonization and integration of QI initiatives? Would improved harmonization of QI

approaches have the potential to increase sustainability and strengthen health systems? In collaboration with the AQUA Institute and the Public Health Institute of the University of Heidelberg, evaplan hosted the Quality Forum from June 19th - 20th in Heidelberg. The goal of the Quality Forum was to use country examples to explore harmonization and integration of quality improvement initiatives and the link to health systems strengthening (documentation will soon be available on our website).

Considering the very positive

feedback, we are planning a second Quality Forum in Summer 2015.
